PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Wage Freeze Regulations 1982, Amendment No. 35, and shall be read together with and deemed part of the Wage Freeze Regulations 1982* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 20th day of November 1984.

- 2. Fourth Schedule amended—The Fourth Schedule to the principal regulations (as added by regulation 9 of the Wage Freeze Regulations 1982, Amendment No. 2) is hereby amended by revoking clause 147 (as added by regulation 3 (2) of the Wage Freeze Regulations 1982, Amendment No. 33), and substituting the following clause:
- "147. An instrument or instruments entered into with Joint Venture Züblin Williamson and any contractors or subcontractors to Joint Venture Züblin Williamson to prescribe provisions relating to shift work and clothing allowances for shift workers, these to modify and add to the provisions relating to shift work and to clothing contained in clauses 3 (d), 3 (h), 3 (j), 4 (a), 7 (b), and 22 (b) of Document No. 1066, the Clyde Dam Construction Employees Composite Agreement, dated 12 December 1983."
 - 3. Revocations—The following regulations are hereby revoked—
 - (a) Regulation 4 of the Wage Freeze Regulations 1982, Amendment No. 22; and
 - (b) Regulation 4 (2) of the Wage Freeze Regulations 1982, Amendment No. 34.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 20 November 1984, vary the wage freeze.

Regulation 2 restates and slightly expands the exemption that applies under the Fourth Schedule to the principal regulations in respect of certain instruments entered into with Joint Venture Züblin Williamson and any contractors or subcontractors to Joint Venture Züblin Williamson.

Regulation 3 effects 2 revocations of a tidying-up nature.

Issued under the authority of the Regulations Act 1986. Date of notification in *Gazette*: 20 November 1984. These regulations are administered in the Department of Labour.
