

# THE WESTPORT HARBOUR REGULATIONS 1965, AMENDMENT NO. 5

#### ORDER IN COUNCIL

At the Government House at Wellington this 23rd day of May 1977

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 232 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Westport Harbour Regulations 1965, Amendment No. 5, and shall be read together with and deemed part of the Westport Harbour Regulations 1965\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Expenses of pilot detained onboard—Regulation 40 of the principal regulations is hereby amended by omitting the expression "\$20" (as substituted by regulation 2 of the Westport Harbour Regulations 1965, Amendment No. 3), and substituting the expression "\$30".
- 3. Pilotage—Regulation 47 of the principal regulations (as substituted by Regulation 3 of the Westport Harbour Regulations 1965, Amendment No. 3) is hereby amended:

(a) By omitting the expression "2 cents", and substituting the expression "4 cents"; and

(b) By omitting the expression "5 cents", and substituting the expression "8 cents".

4. Berthage—Regulation 48 of the principal regulations (as substituted by Regulation 4 of the Westport Harbour Regulations 1965, Amendment No. 3), is hereby amended:

(a) By omitting the expression "3 cents", and substituting the ex-

pression "5 cents";

(b) By omitting the expression "2 cents", and substituting the expression "3 cents";

(c) By omitting the expression "\$5" and substituting the expression "\$10";

"\$13".

- (d) By omitting the expression "\$3" and substituting the expression "\$4"; and (e) By omitting the expression "\$10", and substituting the expression
- 5. Warps and swinging wires—Regulation 54 of the principal regulations is hereby amended by omitting the expression "\$6" (as substituted by Regulation 6 of the Westport Harbour Regulations 1965, Amendment No. 3), and substituting the expression "\$10".
- 6. Electricity—Regulation 55 of the principal regulations (as substituted by Regulation 7 of the Westport Harbour Regulations 1965, Amendment No. 3) is hereby amended:

(a) By omitting the expression "1 cent" and substituting the expres-

sion "2 cents"; and

- (b) By omitting the expression "\$6" and substituting the expression "\$10".
- 7. Charges for towing—Regulation 56 of the principal regulations (as substituted by Regulation 8 of the Westport Harbour Regulations 1965, Amendment No. 3) is hereby amended:

(a) By omitting the expression "\$50" and substituting the expression "\$100";

- (b) By omitting the expression "\$25" and substituting the expression "\$50"; and
- (c) By omitting the expression "\$20" and substituting the expression **"\$**50".
- 8. Laying-up charges—Regulation 64A (1) of the principal regulations (as inserted by Regulation 5 of the Westport Harbour Regulations 1965, Amendment No. 2 and amended by Regulation 9 of the Westport Harbour Regulations 1965, Amendment No. 3) is hereby further amended by revoking paragraphs (a) and (b), and substituting the following paragraph:

"(a) Two cents per ton per day or part thereof whether or not

moored to a wharf or to another vessel."

9. Wharfage rates—The principal regulations are hereby further amended by revoking Regulation 82 (as substituted by Regulation 10 of the Westport Harbour Regulations 1965, Amendment No. 3), and substituting the following regulation:

"82. Wharfage at the following rates shall be payable to the Department in respect of all goods landed on or shipped from any of the wharves or landing places in the Harbour under the control

of the Department:
