## THE WAR INJURIES TO CIVILIANS EMERGENCY REGULATIONS 1942, AMENDMENT NO. 1

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

- 1. These regulations may be cited as the War Injuries to Civilians Emergency Regulations 1942, Amendment No. 1, and shall be read together with and deemed part of the War Injuries to Civilians Emergency Regulations 1942\* (hereinafter referred to as the principal regulations).
- 2. Regulation 4 of the principal regulations is hereby amended as follows:—
  - (a) By omitting from paragraph (a) of subclause (1) the expression "£78", and substituting the expression "£104":
  - (b) By omitting the expression "£104" where it first occurs in paragraph (b) of subclause (1), and substituting the expression "£130":
  - (b) By omitting from paragraph (b) of subclause (1) the expression "£26", and substituting the expression "£27 6s.".
- 3. Regulation 5 of the principal regulations is hereby amended by omitting the expression "£26", and substituting the expression "£27 6s.".
- **4.** Regulation 6 of the principal regulations is hereby amended by omitting the expression "£26" where it first occurs, and substituting the expression "£39".

- 5. Regulation 7 of the principal regulations is hereby amended as follows:—
  - (a) By omitting from paragraph (a) of subclause (1) the expression "£52", and substituting the expression "£78":
  - (b) By omitting from subparagraph (i) of paragraph (b) of subclause (1) the words "One hundred and four pounds", and substituting the words "One hundred and fifty-six pounds":
  - (c) By omitting from subparagraph (iii) of paragraph (b) of subclause (1) the words "Twenty-six pounds", and substituting the words "Twenty-seven pounds six shillings".
- 6. These regulations shall apply with respect to every instalment of a pension (whether granted before or after the commencement of these regulations) if the instalment is payable in respect of any period commencing after the 30th day of June, 1943.
