THE WOOL LEVY REGULATIONS 1945, AMENDMENT NO. 5

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 23 of the Wool Industry Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Wool Levy Regulations 1945, Amendment No. 5, and shall be read together with and deemed part of the Wool Levy Regulations 1945* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1974.

2. Maximum rates of wool levy—The principal regulations are hereby amended by revoking regulation 4 (as substituted by regulation 2 of the Wool Levy Regulations 1945, Amendment No. 3, and amended by regulation 2 of the Wool Levy Regulations 1945, Amendment No. 4), and substituting the following regulation:

"4. (1) The maximum rate of levy that may be charged on wool pursuant to section 12 of the said Act shall be—

"(a) On all shorn wool, being greasy, washed, scoured, or carbonised wool,—

"(i) Delivered to a wool manufacturer for use in New Zealand, 3 percent of the gross proceeds received by the wool-grower for that wool:

"(ii) Exported from New Zealand before being delivered to a wool manufacturer for use in New Zealand, 3 percent of the gross proceeds received by the woolgrower for that wool:

Amendment No. 1: (Revoked by S.R. 1962/164) Amendment No. 2: (Revoked by S.R. 1964/69) Amendment No. 3: S.R. 1964/69 Amendment No. 4: S.R. 1970/117 "(b) On each kilogram of slipe or fellmongered wool delivered to a wool manufacturer for use in New Zealand, or exported from New Zealand before such delivery, a rate not exceeding 3 percent of the sum of—

"(i) An amount equal to the average price per kilogram paid for greasy wool sold by auction in New Zealand during the previous wool sale season ending with the 30th day of June in each year; and

"(ii) Twenty percent of that amount:

"(c) On all wool on the skin delivered to a wool manufacturer for use in New Zealand, or exported from New Zealand before such delivery, a rate per skin calculated in accordance with the following formula:

a X b

Where----

- a is the assessed average wool weight for the particular class of skin as set out in the Second Schedule to these regulations; and
- b is the rate of levy expressed in paragraph (b) of this subclause.

"(2) For the purposes of paragraph (a) of subclause (1) of this regulation, the term "gross proceeds" means the gross price at which the wool was sold by the woolgrower without any deduction or allowance from that gross price whatsoever."

3. Second Schedule added—The principal regulations are hereby further amended by adding the Schedule set out in the Schedule to these regulations.

4. Revocations—The following regulations are hereby consequentially revoked—

(a) The Wool Levy Regulations 1945, Amendment No. 3:

(b) The Wool Levy Regulations 1945, Amendment No. 4.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe the maximum rate of levy that may be charged on wool pursuant to section 12 of the Wool Industry Act 1944. The rate of levy, in the case of shorn wools, is based on a percentage of the gross return to the grower. The rate of levy in the case of slipe and fellmongered wools is based on the average kilogram price received at auction for greasy wool during the previous wool sale season, and in the case of wool on the skin, is based on an assessed average wool weight per skin.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 27 June 1974. These regulations are administered in the Ministry of Agriculture and Fisheries.
