THE WHANGAREI MILK DISTRICT ORDER 1954

ORDER IN COUNCIL

At the Government House at Wellington this 15th day of December 1954

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Whangarei Milk District Order 1954.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The Whangarei Milk District, as constituted by the Whangarei Milk District Constitution Order 1945*, shall hereafter consist of the Borough of Whangarei, the Town District of Kamo, and part of the County of Whangarei; and the boundaries of the said district shall be those specified in the Schedule hereto.

3. The Whangarei Borough Council shall continue to be the Milk Authority of the said district.

4. The Kamo Town Board shall continue to be entitled to have a representative on the Milk Committee of the Whangarei Borough Council and from time to time to nominate one person for that purpose. The person holding office at the commencement of this order as the representative of the Kamo Town Board on the said Milk Committee shall continue in that office until his successor is appointed on such nomination as aforesaid.

5. The Whangarei Borough Council shall from time to time appoint to the Milk Committee of the Borough Council the person nominated by the Kamo Town Board pursuant to clause 4 hereof.

6. This order is in substitution for the Whangarei Milk District Constitution Order 1945,* and that order is hereby revoked.

SCHEDULE

THE WHANGAREI MILK DISTRICT

ALL that area in the North Auckland Land District bounded by a line commencing at the intersection, in Block V, Purua Survey District, of the south-eastern side of the Whangarei-Opua Railway, and a right line parallel to, and 250 links distant in a north-easterly direction from, the north-eastern side of that part of Sewells Road forming the south-western boundary of Allotment 37, Parish of Whangarei, and running south-easterly generally along right lines parallel to, and 250 links distant from, that side of the said road to the right bank of the Waitaua River in Block VIII, Purua Survey District; thence up that bank of the aforesaid river to the boundary of the Kamo Town District; thence again south-easterly along the eastern boundary of that town district, as described in the Proclamation published in *New Zealand Gazette* No. 8 of the 14th day of February 1929, page 385, to the boundary of the Borough of Whangarei; thence north-easterly and then easterly along the northern boundary of the said borough, as described in *New Zealand Gazette* No. 45 of the 7th day of June 1951, page 819, to and along a right line parallel to, and 250 links distant in a north-westerly direction from, the north-western side of the part of Speddings Road forming the south-eastern boundary of Lot 6 on D.P. 7188, being part of Allotment 2, Parish of Whangarei, and along right lines parallel to, and 250 links distant from, the north-western side of the remaining part of Speddings Road aforesaid and the northern side of Kiripaka Road to the right bank of the Hatea River; thence down that right bank to a point in Block V, Whangarei Survey District, due west of the northern corner of the area of 2 acres and 18·6 perches, being part of Allotment W. 17, Parahaki Parish, taken for waterworks by Proclamation published in *New Zealand Gazette* No. 26 of the 19th day of April 1945, page 400, and shown on S.O. Plan 33393; thence along a right line to that northern corner, and along the north-eastern boundary of the aforesaid area of 2 acres and 18·6 perches for a distance of 250 links; thence south-westerly generally along right lines parallel to, and 250 links distant from, the south-eastern side of Whareora Road to and along the eastern and southern boundaries of the Borough of Whangarei aforesaid, to and up the middle of the Raumanga Stream, to a point in Block XVI, Purua Survey District, in line with the southern boundary of Lot 2 on D.P. 26258, being part Waihoanga No. 1 Block; thence along a right line to and along that last-mentioned boundary and along another right line being that boundary produced to the western side of Austins Road; thence northerly along the western side of that road and along a right line being that side produced to a point 250 links distant from, measured at right angles to, the northern side of Maunu Road; thence north-easterly and then northerly along right lines parallel to, and 250 links distant from, the northern and north-western sides of Maunu Road aforesaid, to and along the western

boundary of the Borough of Whangarei aforesaid, to and along the western boundary of the Kamo Town District aforementioned, to and along the northern, eastern, and south-eastern sides of the Whangarei-Opua Railway aforementioned, to the point of commencement: as the same is delineated on the plan marked N.Z.M.B. 1/77, deposited in the office of the New Zealand Milk Board at Wellington, and thereon edged pink.
