ORDER IN COUNCIL

THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL

PURSUANT to section 75c of the War Pensions Act 1954 and to the Royal Powers Act 1983, Her Majesty the Queen, acting by and with the advice and consent of Her Executive Council, is pleased to make the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the War Pensions (Rates of Pensions and Allowances) Order 1986.
- (2) This order shall be deemed to have come into force on the 15th day of January 1986.
- 2. Increasing rates of certain pensions and allowances on and after 15 January 1986—Each provision of the War Pensions Act 1954 specified in the first column of the Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.
- **3. Revocation**—The War Pensions (Rates of Pensions and Allowances) Order (No. 3) 1985* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order increases the rates of the following pensions and allowances on and after 15 January 1986.

- (a) Economic pension payable in conjunction with-
 - (i) Disablement pensions;
 - (ii) Widows' pensions; and
 - (iii) Widowed mothers' pensions:
- (b) Wives' pensions:
- (c) War veterans' allowances and war veterans' allowance gratuities:
- (d) War service pensions:
- (e) War orphans' pensions.

The increase is \$5.56 a week for unmarried persons and \$9.28 a week for married couples. The additional amount payable for the first child of a solo parent pensioner is increased by \$3.72 to \$70.71 a week.

The rate of orphans' pensions is increased by \$2.74 to \$57.79 a week.
