ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 75c of the War Pensions Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the War Pensions (Rates of Pensions and Allowances) Order 1987.
- (2) Clauses 2 and 5 of, and the First Schedule to, this order shall be deemed to have come into force on the 1st day of October 1986.
- (3) Clauses 3 and 4 of, and the Second and Third Schedules to, this order shall be deemed to have come into force on the 1st day of April 1987.
- 2. Increasing rates of pensions and allowances in respect of period 1 October 1986 to 31 March 1987—In respect of the period which commenced on the 1st day of October 1986 and ended with the 31st day of March 1987, the War Pensions Act 1954 shall have effect as if each provision of that Act specified in the first column of the First Schedule to this order had been amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

- 3. Increasing rates of disablement and war widows' pensions and allowances on and after 1 April 1987—Each provision of the War Pensions Act 1954 specified in the first column of the Second Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.
- 4. Increasing rates of economic and war service pensions and war veterans' allowances, etc., on and after 1 April 1987—Each provision of the War Pensions Act 1954 specified in the first column of the Third Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.
 - **5. Revocations**—The following orders are hereby revoked:
 - (a) The War Pensions (Rates of Pensions and Allowances) Order 1985*:
 - (b) The War Pensions (Rates of Pensions and Allowances) Order (No. 2) 1986†.

EXPLANATORY NOTE

This note is not part of the order, but it is intended to indicate its general effect.

Clause 2 of this order increases, on and after 1 October 1986, the following war pensions and allowances:

- (a) Maximum rate of disablement pension by \$4.40 to \$92.55 a week. This will also allow proportionate increases in pensions for partial disablement:
- (b) Maximum rate of additional pension in respect of cases of severe disablement by \$2.64 to \$55.53 a week:
- (c) Clothing allowances by 49c to \$10.32 a week in respect of loss of 2 limbs, by 47c to \$9.95 a week in respect of loss of leg or part, and by 34c to \$7.22 a week in respect of loss of an arm or use of a mechanical appliance or soiling of clothing:
- (d) Maximum rate of war widows' pensions by \$3.25 to \$68.28 a week.

In addition, clause 2 increases, on and after 1 October 1986, the following war pensions and allowances:

- (a) Economic pensions payable in conjunction with—
 - (i) Disablement pensions;
 - (ii) Widows' pensions; and
 - (iii) Widowed mothers' pensions:
- (b) Wives' pensions:
- (c) War veterans' allowances and war veterans' allowance gratuities:
- (d) War service pensions:
- (e) War orphans' pensions.

The rates of pensions are increased by \$13.45 a week for unmarried persons without children, by \$22.42 a week for unmarried persons with children, by \$22.42 a week for married couples without children, and by \$22.42 a week for married couples with children.

The mother's allowance payable for the first child of a war widow is increased by \$8.97 to \$83.44 a week.

The rate of orphans' pensions is increased by \$6.63 to \$65.73 a week.

The maximum rate of war veteran's allowance payable to a widow is increased to \$199.44 a week.

NOTE—The "amendment" to the Second Schedule to the War Pensions Act 1954 set out in the First Schedule to this order does not increase the amount payable. This has been done to enable the revocation of the War Pensions (Rates of Pensions and Allowances) Order (No. 2) 1986, in its entirety, as from 1 October 1986.

Clause 3 of this order increases, on and after 1 April 1987, the following war pensions and allowances:

- (a) Maximum rate of disablement pension by \$11.73 to \$104.28 a week. This will also allow proportionate increases in pensions for partial disablement:
- (b) Maximum rate of additional pension in respect of cases of severe disablement by \$7.04 to \$62.57 a week:
- (c) Clothing allowances by \$1.31 to \$11.63 a week in respect of loss of 2 limbs, by \$1.26 to \$11.21 a week in respect of loss of leg or part, and by 92c to \$8.14 a week in respect of loss of an arm or use of a mechanical appliance or soiling of clothing:
- (d) Maximum rate of allowances for services of attendants for disabled pensioners by \$29.87 to \$193.16 a week:
- (e) Maximum rate of war widows' pensions by \$8.65 to \$76.93 a week.

Clause 4 of this order increases, on and after 1 April 1987, the following war pensions and allowances:

- (a) Economic pensions payable in conjunction with—
 - (i) Disablement pensions;
 - (ii) Widows' pensions; and
 - (iii) Widowed mothers' pensions:
- (b) Wives' pensions:
- (c) War veterans' allowances and war veterans' allowance gratuities:
- (d) War service pensions:
- (e) War orphans' pensions.

The rates of pensions are increased by \$8.09 a week for unmarried persons without children, by \$13.48 a week for unmarried persons with children, by \$13.48 a week for married couples without children, and by \$13.48 a week for married couples with children.

The mother's allowance payable for the first child of a war widow in increased by \$5.39 to \$88.83 a week.

The rate of orphans' pensions is increased by \$3.99 to \$69.72 a week. The maximum rate of war veteran's allowance payable to a widow is increased to \$216.18 a week.
