**ORDER IN COUNCIL**

At Wellington this 7th day of March 1994

Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 75C of the War Pensions Act 1954, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

**ORDER**

**1. Title and commencement**—(1) This order may be cited as the War Pensions (Rates of Pensions and Allowances) Order 1994.

(2) This order shall come into force on the 1st day of April 1994.

**2. Increasing rates of pensions and allowances on and after 1 April 1994**—Each provision of the War Pensions Act 1954 specified in the first column of the Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

**3. Revocation**—The War Pensions (Rates of Pensions and Allowances) Order 1993\* is hereby revoked.

## EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order increases, on and after 1 April 1994, the following war pensions and allowances:

- (a) Maximum rate of disablement pension by \$1.82 to \$133.09 a week. This will also allow proportionate increases in pensions for partial disablement:
- (b) Maximum rate of additional pension in respect of cases of severe disablement by \$1.09 to \$79.85 a week:
- (c) Clothing allowance by 20c a week in respect of the loss of 2 limbs or parts, by 19c a week in respect of the loss of a leg or part, and by 14c a week in respect of the loss of an arm or part or the use of any mechanical or other appliance (other than an artificial leg or artificial arm) or a disability which causes or leads to soiling of clothing:
- (d) Maximum rate of allowances for services of attendants for disabled pensioners by \$3.37 to \$246.53 a week:
- (e) Maximum rate of surviving spouses' pensions by \$1.34 to \$98.19 a week:
- (f) Maximum rate of additional parent's allowance payable to a surviving spouse on account of first or only dependent child, by \$1.42 to \$104.27 a week, and for each subsequent child by 22c to \$16.59 a week:
- (g) Maximum rate of children's pension in ordinary cases by 8c to \$6.16 a week:
- (h) Maximum rate of a war orphan's pension by \$1.12 to \$82.24 a week.
