This order is the War Pensions (Rates of Pensions and Allowances) Order 2001.

3 Increasing rates of pensions and allowances

Each provision of the War Pensions Act 1954 listed in column 1 of the Schedule of this Order is amended by omitting the expression set out opposite to it in column 2, and substituting in each case the expression set out opposite to it in column 3.

The War Pensions (Rates of Pensions and Allowances) Order 2000 (SR 2000/46) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 April 2001, amends the War Pensions Act 1954. It increases the following war pensions and allowances in accordance with the All Groups Consumer Price Index of 3.98%:

- the maximum rate of a disablement pension:
- the maximum rate of additional pension for severe disablement:
- clothing allowances:
- the maximum rate of allowance for the services of attendants for disabled pensioners:
- the maximum rate of surviving spouses' pensions:
- the maximum rate of additional parents' allowances payable to a surviving spouse:
- the maximum rate of children's pension in ordinary cases:
- the maximum rate of a war orphan's pension.
