ORDER IN COUNCIL

At Wellington this 14th day of July 1986

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 75C of the War Pensions Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the War Pensions (Rates of Pensions and Allowances) Order (No. 2) 1986.

(2) This order shall be deemed to have come into force on the 1st day of April 1986.

2. Increasing rates of disablement and war widows' pensions and allowances—Each provision of the War Pensions Act 1954 specified in the first column of the First Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

3. Increasing rates of economic and war service pensions and war veterans' allowances, etc.—Each provision of the War Pensions Act 1954 specified in the first column of the Second Schedule to this order is hereby amended by omitting every expression set out opposite to it in the second column of that Schedule, wherever that expression occurs, and substituting in each case the expression set out opposite to it in the third column of that Schedule.

4. Revocations—The following orders are hereby revoked:

- (a) The War Pensions (Rates of Pensions and Allowances) Order (No. 2) 1985*:

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

Clause 2 of this order increases, on and after 1 April 1986, the following war pensions and allowances:

- (a) Maximum rate of disablement pensions by \$10.11 to \$88.15 a week. This will also allow proportionate increases in pensions for partial disablement:
- (b) Maximum rate of additional pension payable in respect of cases of severe disablement by \$6.07 to \$52.89 a week:
- (c) Clothing allowances by \$1.13 to \$9.83 a week in respect of loss of 2 limbs, by \$1.09 to \$9.48 a week in respect of loss of a leg, and by 79c to \$6.88 a week in respect of loss of an arm or use of a mechanical appliance or soiling of clothing:
- (d) Maximum rate of allowances for services of attendants for disabled pensioners by \$18.73 to \$163.29 a week:
- (e) Maximum rate of war widows' pensions by \$7.46 to \$65.03 a week.

Clause 3 of this order increases, on and after 1 April 1986, the following war pensions and allowances:

- (a) Economic pension payable in conjunction with—
 - (i) Disablement pensions;
 - (ii) Widows' pensions; and
 - (iii) Widowed mothers' pensions:
- (b) Wives' pensions:
- (c) War veterans' allowances and war veterans' allowance gratuities:
- (d) War service pensions:
- (e) War orphans' pensions.

The increase is \$2.66 a week for unmarried persons and \$4.42 a week for married couples.

The additional amount payable for the first child of a solo parent pensioner is increased by \$1.76 to \$72.47 a week

The rate of orphans' pensions is increased by \$1.31 to \$59.10 a week.

The clause also increases the maximum rate of war veteran's allowance payable to a widow to \$182.74 a week.
