#### Order

#### 1 Title

This order is the War Pensions (Rates of Pensions, Lump Sum Payments, and Allowances) Order 2005.

#### 2 Commencement

This order comes into force on 1 April 2005.

# 3 Increasing rates of pensions, lump sum payments, and allowances

- (1) Each provision of the War Pensions Act 1954 listed in column 1 of the Schedule of this order is amended by omitting the expression set out opposite to it in column 2 in each place where that expression appears, and substituting in each case the expression set out opposite to it in column 3.
- (2) The amendments made by subclause (1) to Schedule 12 of the War Pensions Act 1954 apply in respect of persons who die on or after 1 April 2005.

#### 4 Revocation

The War Pensions (Rates of Pensions, Lump Sum Payments, and Allowances) Order 2004 (SR 2004/58) is revoked.

This order, which comes into force on 1 April 2005, amends the War Pensions Act 1954. It increases the following war pensions, lump sum payments, and allowances in accordance with an increase of 2.70% in the All Groups Consumers Price Index:
