## THE WAR PENSIONS REGULATIONS 1945, AMENDMENT NO. 2

# B. C. FREYBERG, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 6th day of December, 1949

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL PURSUANT to the War Pensions Act, 1943, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the War Pensions Regulations 1945, Amendment No. 2, and shall be read together with and deemed part of the War Pensions Regulations 1945\* (hereinafter referred to as the principal regulations).
- 2. Regulation 22 of the principal regulations is hereby amended by omitting the words "one month after the earliest date on which the pensioner or his agent is entitled to collect it", and substituting the words "such time as the Secretary may allow in that behalf, being not more than one month after the end of the month in which authority to collect the instalment is given".
- 3. Regulation 33 of the principal regulations is hereby amended by omitting from subclause (2) the expression "15s.", and substituting the expression "20s."
- **4.** Rule 9 of the Schedule to the principal regulations is hereby amended by revoking paragraphs (d) and (e), and substituting the following paragraphs:—
  - "(d) For medical examination and completion of form

    patient's discharge from that institution ... 0 10 6
  - "(e) For medical examination and completion of form
    War 11 in any case to which paragraph (d)
    hereof does not apply . . . . . 1 1 0"
- 5. (1) Rule 10 of the Schedule to the principal regulations is hereby amended as follows:—
  - (a) By omitting from subclause (2) the words "at a rate":
  - (b) By omitting from subclause (2) the expression "17s. 6d.", and substituting the expression "25s."

- (2) Rule 10 of the Schedule to the principal regulations is hereby further amended by revoking subclause (3), and substituting the following subclause:—
- "(3) Where a member of the Forces is required to report for medical examination or treatment, or for attendance at the Appeal Board, compensation for loss of earnings may, at the discretion of the Secretary, be paid at a rate not exceeding 13s. 9d. for every half-day or fraction of a half-day, but not in any case exceeding the amount of earnings lost. Where any claim under this subclause relates to wages it must be accompanied by a certificate from the member's employer, or (if the member is not an employee) by a certificate from a person employed and paid by him to do his work."
- 6. (1) The Schedule to the principal regulations is hereby amended by revoking Rule 13, and substituting the following rule:—
- "13. (1) Any person who is in receipt of a permanent pension in respect of his total disablement may, on application to the Secretary, be provided with a free pass to enable him to travel by the New Zealand Government Railways rail services first class, and by the New Zealand Government Railways road services.
- "(2) Where any person to whom subclause (1) of this rule applies is totally blind or has suffered the loss of both lower limbs above the knee, or is otherwise unfit to travel alone, he may, at the discretion of the Secretary, be provided, on application, with a specially endorsed pass to enable an escort to travel with him free of cost by the New Zealand Government Railways rail and road services.
- "(3) A person who, in respect of a disability which impedes locomotion, is in receipt of a permanent pension at a rate exceeding 50 per cent. of the pension payable for total disablement may, at the discretion of the Secretary, be provided, on application, with a pass to enable him to travel by the New Zealand Government Railways rail services first class at second-class rates."
- (2) The regulations entitled the War Pensions Regulations 1945, Amendment No. 1, are hereby consequentially revoked.
