

THE WAR PENSIONS REGULATIONS 1956, AMENDMENT NO. 15

Pursuant to the War Pensions Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the War Pensions Regulations 1956, Amendment No. 15, and shall be read together with and deemed part of the War Pensions Regulations 1956* (hereinafter referred to as the principal regulations).

(2) Regulations 2 and 6 of these regulations shall come into force on

the day after the date of their notification in the Gazette.

(3) Regulation 3 of these regulations shall be deemed to have come into force on the 1st day of November 1973.

(4) Regulation 4 of and the First Schedule to these regulations shall be deemed to have come into force on the 1st day of November 1974.

(5) Regulation 5 of these regulations shall be deemed to have come into force on the 1st day of April 1974.

(6) Regulation 7 of and the Second Schedule to these regulations shall be deemed to have come into force on the 1st day of January 1974.

- 2. Persons authorised to receive declarations—Regulation 4 of the principal regulations (as substituted by regulation 3 of the War Pensions Regulations 1956, Amendment No. 7) is hereby amended by inserting, after the word "Accountants,", the words "any member of the Practising Accountants Association of New Zealand (Incorporated),".
- 3. Alteration of fees payable for medical examinations in respect of period 1 November 1973 to 31 October 1974—In respect of the period commencing on the 1st day of November 1973 and ending with the 31st day of October 1974, the principal regulations shall have effect as if the Second Schedule (as substituted by regulation 2 (1) of the War Pensions Regulations 1956, Amendment No. 11) had been amended in the following manner:

(a) By omitting from clause 1 the expression "10.50", and substituting the expression "12.50":

(b) By omitting from clause 2 the expression "8.40", and substituting the expression "10.00":

(c) By omitting from clause 3 the expression "7.35", and substituting the expression "8.50":

(d) By omitting from clause 4 the expression "6.30", and substituting the words "No specified fee*":

(e) By omitting from clause 5 the expression "2.00", and substituting the expression "4.00":

(f) By omitting from clause 6 the expression "2.50", and substituting the expression "6.00":

(g) By omitting from clause 7 the expression "3.00", and substituting the expression "10.00":

(h) By repealing clause 8, and substituting the following clause:
"8. Medical travel fee—

For each mile travelled from surgery or residence 0.35":

(i) By omitting from clause 9 the expression "5.00", and substituting the words "No specified fee*":

(j) By adding the following footnote:

"*Fees over \$12 subject to approval of departmental medical officer".

- 4. Alteration of fees payable for medical examinations on and after 1 November 1974—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 (1) of the War Pensions Regulations 1956, Amendment No. 11), and substituting the Second Schedule set out in the First Schedule to these regulations.
 - (2) The following regulations are hereby revoked:

(a) Regulation 2 of, and the First Schedule to, the War Pensions Regulations 1956, Amendment No. 11:

(b) Regulation 5 of the War Pensions Regulations 1956, Amendment No. 12.

5. Increasing travelling allowances—(1) The principal regulations are hereby amended by revoking regulation 44, and substituting the following regulation:

- "44. Any person who is in receipt of a permanent pension in respect of his total disablement, or who is and has continuously during the 3 years immediately past been in receipt of a temporary pension in respect of his total disablement, and who in either case is totally blind or has suffered the loss of both legs above the knee or is otherwise unfit to travel alone may, at the discretion of the Secretary, be granted a travelling allowance or allowances in respect of the personal expenses of himself and his escort (if any) not exceeding \$2.30 a week."
 - (2) The following regulations are hereby revoked:
 - (a) Regulation 4 of the War Pensions Regulations 1956, Amendment No. 3:
 - (b) Regulation 2 of the War Pensions Regulations 1956, Amendment No. 13.
- 6. Boarding allowances—(1) The principal regulations are hereby further amended by revoking regulation 54, and substituting the following regulation:
- "54. (1) If, in the opinion of the Director-General of Education, any student who has been granted a war bursary under the provisions of these regulations is obliged to live away from home for the purpose of pursuing his studies, there may, in the discretion of the Director-General, be paid in respect of that student a boarding allowance at a rate not exceeding that specified in the regulations administered by the Department of Education governing the payment of boarding allowances in respect of students attending secondary school, university, or a technical institute:

"Provided that the Director-General may, in his discretion, withhold payment of a boarding allowance granted under this regulation in respect of any period during which the student is in regular employment.

- "(2) Applications for boarding allowances under this regulation shall be made to the Director-General of Education."
- (2) The Seventh Schedule to the principal regulations is hereby revoked.
- (3) Regulation 9 of and the Schedule to the War Pensions Regulations 1956, Amendment No. 7, are hereby consequentially revoked.
- 7. Increasing rates of war bursaries—(1) The principal regulations are hereby further amended by revoking the Sixth Schedule (as substituted by regulation 3 of the War Pensions Regulations 1956, Amendment No. 10), and substituting the Sixth Schedule set out in the Second Schedule to these regulations.
 - (2) The following regulations are hereby revoked:
 - (a) Regulation 3 of, and the Schedule to, the War Pensions Regulations 1956, Amendment No. 10:

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 provides for members of the Practising Accountants Association of New Zealand to be authorised to receive declarations for war pension purposes. Regulation 3 provides for a revised Schedule of fees payable for medical examinations in respect of the period 1 November 1973 to 31 October 1974.

Regulation 4 provides for a revised Schedule of fees payable for medical

examinations on and after 1 November 1974.

Regulation 5 provides for an increase in the rate of travelling allowances for seriously disabled war pensioners, from \$2 to \$2.30 a week.

Regulation 6 provides for the rates of boarding allowances for war bursars to be based on the rates of boarding allowances granted under regulations administered by the Department of Education. This avoids the necessity of setting out the rates of boarding allowances in the Seventh Schedule to the principal regulations.

Regulation 7 provides for increases in the rates of war bursaries payable to secondary school children, technical institute students, and university students.
