THE WAR PENSIONS REGULATIONS 1956, AMENDMENT NO. 17

PURSUANT to the War Pensions Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the War Pensions Regulations 1956, Amendment No. 17, and shall be read together with and deemed part of the War Pensions Regulations 1956* (hereinafter referred to as the principal regulations).

(2) Regulation 2 of, and the Schedule to, these regulations shall be deemed to have come into force on the 1st day of November 1975.

(3) Regulation 3 of these regulations shall be deemed to have come into force on the 1st day of December 1976.

(4) Regulation 4 of these regulations shall be deemed to have come into force on the 1st day of April 1976.

2. Alterations of fees payable for medical examinations on and after 1 November 1975—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 4 (1) of the War Pensions Regulations 1956, Amendment No. 15), and substituting the Second Schedule set out in the Schedule to these regulations.

(2) Regulations 3 and 4 of, and the First Schedule to, the War Pensions Regulations 1956, Amendment No. 15, are hereby consequentially revoked.

3. Permanent travelling concessions—The principal regulations are hereby further amended by inserting, after regulation 43A, the following regulation:

"43B. Any person holding a pass provided under subclause (1) or subclause (2) of regulation 43 hereof wishing to travel by way of a privately-owned transport service on a route where New Zealand Government Railways rail or road services have previously been withdrawn may, on application to the Secretary, be provided with a warrant for the fare."

4. Increasing travelling allowances—(1) Regulation 44 of the principal regulations (as substituted by regulation 5 (1) of the War Pensions Regulations 1956, Amendment No. 15 and amended by regulation 2 of the War Pensions Regulations 1956, Amendment No. 16), is hereby further amended by omitting the expression "\$2.60", and substituting the expression "\$3.05".

(2) Regulation 2 of the War Pensions Regulations 1956, Amendment No. 16, is hereby consequentially revoked.

Boxing Day, New Year's Day, the 2nd day of January, Waitangi Day, Good Friday, Easter Monday, Anzac Day, Sovereign's Birthday, Labour Day, and the holiday observed in the locality concerned as Anniversary Day; and includes, when any of the above-named public holidays (other than Waitangi Day and Anzac Day) that can fall on a Saturday or Sunday so falls, the day that is observed in the locality concerned as a substituted public holiday; and also includes, when Boxing Day falls on a Monday, the day following Boxing Day.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 provides for a revised Schedule of fees payable for medical examinations on and after 1 November 1975.

Regulation 3 provides that disabled pensioners holding a free pass for New Zealand Railways rail and road services may travel by way of a privately-owned transport service where New Zealand Railways services have previously been withdrawn and be provided with a warrant for the fare.

withdrawn and be provided with a warrant for the fare. Regulation 4 provides for an increase in the rate of travelling allowances for seriously disabled war pensioners from \$2.60 to \$3.05 a week on and after 1 April 1976.
