### THE WAR PENSIONS REGULATIONS 1956, AMENDMENT NO. 19

#### ORDER IN COUNCIL

At the Government Buildings at Wellington this 26th day of March 1979

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the War Pensions Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the War Pensions Regulations 1956, Amendment No. 19, and shall be read together with and deemed part of the War Pensions Regulations 1956\* (hereinafter referred to as the principal regulations).

(2) Regulations 2 and 3 of, and the First Schedule to, these regulations shall be deemed to have come into force on the 1st day of April 1978.

(3) Regulation 4 of these regulations shall be deemed to have come into force on the 9th day of February 1977.

(4) Regulation 5 of, and the Second Schedule to, these regulations shall be deemed to have come into force on the 1st day of January 1979.

(5) Regulation 6 of, and the Third Schedule to, these regulations shall be deemed to have come into force on the 1st day of October 1978.

2. Alterations of fees payable for medical examinations on and after 1 April 1978—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 (1) of the War Pensions Regulations 1956, Amendment No. 17), and substituting the Second Schedule set out in the First Schedule to these regulations.

(2) Regulation 2 of, and the Schedule to, the War Pensions Regulations 1956, Amendment No. 17, are hereby consequentially revoked.

3. Increasing travelling allowances—(1) Regulation 44 of the principal regulations (as substituted by regulation 5 (1) of the War Pensions Regulations 1956, Amendment No. 15, and amended by regulation 2 (1) of the War Pensions Regulations 1956, Amendment No. 18) is hereby further amended by omitting the expression "\$3.50", and substituting the expression "\$4.05".

(2) Regulation 2 of the War Pensions Regulations 1956, Amendment No. 18, is hereby consequentially revoked.

4. Secretary may authorise payment of funeral expenses—Regulation 45 (3) of the principal regulations (as added by regulation 3 of the War Pensions Regulations 1956, Amendment No. 14) is hereby amended by revoking paragraph (a), and substituting the following paragraph:

"(a) The deceased ex-serviceman was, at the time of his death, in receipt of an economic pension, a war service pension, a war veteran's allowance, or an invalid's benefit or national superannuation payable under the Social Security Act 1964 if, in the case of national superannuation, the income of the ex-serviceman immediately before his death was such that it would not have prevented the payment of an invalid's benefit under that Act; and".

5. Increasing amounts of war bursaries—(1) The principal regulations are hereby further amended by revoking the Sixth Schedule (as substituted by regulation 3 (2) of the War Pensions Regulations 1956, Amendment No. 18), and substituting the Sixth Schedule set out in the Second Schedule to these regulations.

(2) Regulation 3 (2) and  $\overline{(3)}$  of, and the First Schedule to, the War Pensions Regulations 1956, Amendment No. 18, are hereby consequentially revoked.

6. Increasing amounts of motor vehicle loans—(1) The principal regulations are hereby further amended by revoking the Eighth Schedule (as substituted by regulation 4 (1) of the War Pensions Regulations 1956, Amendment No. 18), and substituting the Eighth Schedule set out in the Third Schedule to these regulations.

(2) Regulation 4 of, and the Second Schedule to, the War Pensions Regulations 1956, Amendment No. 18, are hereby consequentially revoked.

#### MAXIMUM AMOUNTS OF MOTOR VEHICLE LOANS

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 provides for a revised Schedule of fees payable for medical examinations on and after 1 April 1978.

Regulation 3 provides for an increase in the rate of the travelling allowances for seriously disabled war pensioners from \$3.50 to \$4.05 a week on and after 1 April 1978.

Regulation 4 amends regulation 45 of the principal regulations which relates to the payment of an ex-servicemen's funeral expenses in certain circumstances. The amendment deletes a reference to social security age benefit which was replaced by national superannuation in February 1977 and provides for a funeral grant to be paid in respect of an ex-serviceman receiving national superannuation at the time of his death if his income was such that he could have qualified for a social security invalid's benefit on income grounds.

Regulation 5 increases, on and after 1 January 1979, the rates of war bursaries payable to secondary school children, technical institute students, teachers college students, and university students.

Regulation 6 increases, on and after 1 October 1978, the maximum amounts of loans available to war pensioners for the purchase of motor vehicles, as follows:

(a) Loans available to double amputees and paraplegics are increased from \$3,000 to \$3,500:

(b) Loans available to persons receiving a war pension in respect of a permanent locomotive disability assessed at 85 percent or more of total disablement are increased from \$1,200 to \$1,600.
