ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the War Pensions Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the War Pensions Regulations 1956, Amendment No. 25, and shall be read together with and deemed part of the War Pensions Regulations 1956* (hereinafter referred to as the principal regulations).
- (2) Regulations 2 to 4 and 5 (1) of these regulations shall be deemed to have come into force on the 1st day of April 1984.
- (3) Regulation 5 (2) and (3) of these regulations shall be deemed to have come into force on the 1st day of April 1985.
- (4) Regulation 6 of, and the First Schedule to, these regulations shall be deemed to have come into force on the 1st day of May 1985.

- (5) Regulations 7 to 9 of, and the Second to Fourth Schedules to, these regulations shall be deemed to have come into force on the 1st day of October 1985.
- 2. Provision of free railway passes—(1) Regulation 43 (1) of the principal regulations is hereby amended by omitting the words "Government Railways" in both places where they occur, and substituting in each case the words "Railways Corporation".
- (2) Regulation 43 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclauses:
- "(2) Where any person to whom subclause (1) of this regulation applies is totally blind or has suffered the loss of both legs above the knee he may, at the discretion of the Secretary, be provided with a specially endorsed pass to enable himself and an escort to travel free of cost by the New Zealand Railways Corporation rail and road services.
- "(2A) Where any person to whom subclause (1) of this regulation applies receives all or part of his disablement pension in respect of the amputation of all or part of a limb, or is otherwise unfit to travel alone, he may on application, at the discretion of the Secretary, be provided with a specially endorsed pass to enable himself and an escort to travel free of cost by the New Zealand Railways Corporation rail and road services."
- (3) Regulation 43 (3) of the principal regulations (as substituted by regulation 2 of the War Pensions Regulations 1956, Amendment No. 14) is hereby amended by omitting the words "Government Railways", and substituting the words "Railways Corporation".
- **3. Travel on inter-island ferry service**—Regulation 43A of the principal regulations (as substituted by regulation 2 of the War Pensions Regulations 1956, Amendment No. 22) is hereby amended by inserting, after the expression "subclause (2)", the expression "or subclause (2A)".
- **4. Permanent travelling concessions**—Regulation 43B of the principal regulations (as inserted by regulation 3 of the War Pensions Regulations 1956, Amendment No. 17) is hereby amended—
 - (a) By inserting, after the expression "subclause (2)", the expression "or subclause (2A)":
 - (b) By omitting the words "Government Railways", and substituting the words "Railways Corporation".
- **5. Travelling allowances**—(1) The principal regulations are hereby amended by revoking regulation 44, and substituting the following regulation:
 - "44. Any person who is in receipt of—
 - "(a) A permanent pension in respect of his total disablement; or
 - "(b) A temporary pension in respect of his total disablement and who has been continuously in receipt of that pension during the immediately preceding period of 3 years—

and who in either case-

- "(c) Is totally blind; or
- "(d) Receives all or part of his disablement pension in respect of the amputation of all or part of a limb; or
- "(e) Is otherwise unfit to travel alone-

- may, at the Secretary's discretion, be granted a travelling allowance or allowances in respect of the combined personal expenses of himself and his escort (if any) not exceeding \$8.32 a week."
- (2) Regulation 44 of the principal regulations (as substituted by subclause (1) of this regulation) is hereby amended by omitting the expression "\$8.32", and substituting the expression "\$9.44".
 - (3) The following regulations are hereby consequentially revoked:
 - (a) Regulation 5 of the War Pensions Regulations 1956, Amendment No. 15:
 - (b) Regulation 2 of the War Pensions Regulations 1956, Amendment No. 24.
- **6.** Increasing fees payable for medical examinations—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 5 (1) of the War Pensions Regulations 1956, Amendment No. 22), and substituting the Second Schedule set out in the First Schedule to these regulations.
- (2) Regulation 5 of, and the First Schedule to, the War Pensions Regulations 1956, Amendment No. 22 are hereby consequentially revoked.
- **7. Increasing amounts of war bursaries**—(1) The principal regulations are hereby amended by revoking the Sixth Schedule (as substituted by regulation 5 (1) of the War Pensions Regulations 1956, Amendment No. 19), and substituting the Sixth Schedule set out in the Second Schedule to these regulations.
- (2) Regulation 5 of, and the Second Schedule to, the War Pensions Regulations 1956, Amendment No. 19 are hereby consequentially revoked.
- **8.** Increasing amounts of motor vehicle loans—(1) The principal regulations are hereby amended by revoking the Eighth Schedule (as substituted by regulation 3 (1) of the War Pensions Regulations 1956, Amendment No. 24), and substituting the Eighth Schedule set out in the Third Schedule to these regulations.
- (2) Regulation 3 of, and the Schedule to, the War Pensions Regulations 1956, Amendment No. 24 are hereby consequentially revoked.
- 9. Allowances and annuities payable to holders of decorations—(1) The principal regulations are hereby amended by revoking the Tenth and Eleventh Schedules (as added by regulation 3 of the War Pensions Regulations 1956, Amendment No. 8), and substituting the Tenth and Eleventh Schedules set out in the Fourth Schedule to these regulations.
- (2) Regulation 3 of, and the Schedule to, the War Pensions Regulations 1956, Amendment No. 8 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2, which is deemed to have come into force on 1 April 1984, removes the requirement of applying for the issue of a free railway pass to a war disablement pensioner who is totally blind or has suffered the loss of both legs above the knee, and to an escort. The pass may now be issued without application.

In addition it is now provided that such passes (pensioner and escort) may be issued, on application, to war disablement pensioners who receive all or part of their pension in respect of an amputation of all or part of a limb.

Regulations 3 and 4, which are deemed to have come into force on 1 April 1984, apply the new provisions contained in regulation 2 to the inter-island ferry service and to privately-owned transport services on routes where New Zealand Railways Corporation rail or road services have been withdrawn.

Regulation 5 (1), which is deemed to have come into force on 1 April 1984, extends the provision for the payment of travelling allowances for seriously disabled war pensioners to include pensioners who receive all or part of their pension in respect of the amputation of all or part of a limb.

Regulation 5 (2) increases, on and after 1 April 1985, the rate of travelling allowance from \$8.32 to \$9.44 a week.

Regulation 6 increases, on and after 1 May 1985, the fees payable for medical examinations.

Regulation 7 increases, on and after 1 October 1985, the rates of war bursaries payable to secondary school children, technical institute students, teachers college students, and university students.

Regulation 8 increases, on and after 1 October 1985, the maximum amount of loans available for the purchase of motor vehicles. The maximum amount of loan available for double amputees and paraplegics is increased from \$5,850 to \$7,500. The maximum amount of loan available for war pensioners with a permanent locomotive disability assessed at 85 percent or more of total disability is increased from \$2,635 to \$3,875.

Regulation 9 increases, on and after 1 October 1985, the allowances payable to holders of certain specified decorations who are in receipt of a disablement pension. The allowance is increased from \$1 to \$5 a week.

In addition the annuity payable to holders of the Victoria Cross is increased, on and after 1 October 1985, from \$200 to \$1,000.
