

## THE WILDLIFE REGULATIONS 1955, AMENDMENT NO. 18

#### ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 72 of the Wildlife Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Wildlife Regulations 1955, Amendment No. 13, and shall be read together with and deemed part of the Wildlife Regulations 1955\* (hereinafter referred to as the principal regulations).
  - (2) These regulations shall come into force on the 1st day of May 1997.
- 2. New Fifth Schedule substituted—(1) The principal regulations are hereby amended by revoking the Fifth Schedule (as added by regulation 5

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 May 1997, amend the Wildlife Regulations 1955 by substituting a new Fifth Schedule setting out increased licence fees. These increased licence fees take effect from 1 May 1997 and the fee increases range from .50c to a maximum of \$1.00 per licence.
