

### THE WILDLIFE REGULATIONS 1955, AMENDMENT NO. 7

THE HON, N. E. KIRK PRESIDING IN COUNCIL

PURSUANT to the Wildlife Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Wildlife Regulations 1955, Amendment No. 7, and shall be read together with and deemed part of the Wildlife Regulations 1955\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date

of their notification in the Gazette.

2. Availability of licences—Regulation 5 of the principal regulations

is hereby amended by adding the following subclause:

- "(3) Where under subclause (2) of this subclause the Minister has consented to a licence issued by any society being available in the district of any other society, that other society may, on the application of the holder of any such licence and on payment of such fee as the society determines, attach to or endorse on the licence an endorsement in a form approved by the Secretary that the licence is available in its district.
- 3. Licence fees—Regulation 13 of the principal regulations (as substituted by regulation 2 (1) of the Wildlife Regulations 1955, Amendment No. 2) is hereby amended by omitting from the second proviso to subclause (1) the words "the unanimous decision of".
- 4. Metric conversions—(1) The principal regulations are hereby further amended-
  - (a) By omitting from subclause (2) of regulation 18 and also from subclause (3) the words "60 yards", and substituting in each case the words "50 metres":

(b) By omitting from paragraph (c) of regulation 19 the words "100 yards", and substituting the words "90 metres":

(c) By omitting from regulation 20 (as substituted by regulation 5 of the Wildlife Regulations 1955, Amendment No. 1) the words "100 yards", and substituting the words "90 metres".
(2) Regulation 2 of the Wildlife Regulations 1955, Amendment No. 5,

is hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 enables a society, in cases where the Minister has consented to licences in another district being available in that society's district, to endorse any

such licence to that effect at a fee fixed by the society.

Regulation 3 removes the requirement that a decision of the Council of the

Society to issue a complimentary licence must be unanimous.

Regulation 4 effects metric conversions of measurements in the principal regulations. The conversions are not exact, but have been rounded off to convenient figures.
