

THE WHEAT RESEARCH REGULATIONS 1966

At the Government House at Wellington this 18th day of May 1966

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 17 of the Scientific and Industrial Research Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Wheat Research Regulations 1966.
- (2) These regulations shall come into force on the seventh day after the date of their notification in the *Gazette*.
 - 2. In these regulations, unless the context otherwise requires,—
 - "Minister" means the Minister of the Crown for the time being charged by the Governor-General with the administration of the Scientific and Industrial Research Act 1952:
 - "Wheat Research Committee" means the committee of that name appointed by the Minister under section 5A of the Scientific and Industrial Research Act 1952 and consisting of—
 - (a) Two members appointed as representatives of flour-millers:
 - (b) Two members appointed as representatives of bakers:
 - (c) Two members appointed as representatives of wheat-growers:
 - (d) Two members appointed as representatives of the Department of Scientific and Industrial Research:
 - (e) One member appointed as a representative of grain merchants:
 - (f) One member appointed as a representative of Lincoln College:
 - (g) One member appointed as a representative of the Department of Industries and Commerce:
 - (h) One member appointed as a representative of the Department of Agriculture:

- (i) Up to three additional members, one of whom may be appointed as a representative of flourmillers, one of whom may be appointed as a representative of bakers, and one of whom may be appointed as a representative of wheatgrowers on the recommendation of the members mentioned in paragraphs (a), (b), and (c) hereof respectively.
- 3. The provisions of these regulations shall have effect notwithstanding any vacancy for the time being in the membership of the Wheat Research Committee.

4. The following levies are hereby imposed—

(a) On all wheat grown in New Zealand and sold or delivered to a flourmiller or to a grain merchant, there shall be payable by the producer a levy computed at the rate of 6d. for every 50 bushels of wheat so delivered by him:

(b) On all flour and wheatmeal delivered by a flourmill, there shall be payable by the flourmiller a levy computed at the rate of 6d. for every ton of flour or wheatmeal so delivered by him:

(c) On all flour and wheatmeal received from a flourmill, there shall be payable by the person taking delivery thereof a levy computed at the rate of 6d. for every ton thereof.

5. The levies payable in accordance with these regulations by producers and flourmillers shall be collected and paid as follows:

- (a) Every flourmiller or grain merchant who receives from a producer any wheat in respect of which a levy is payable as aforesaid shall deduct from the price of the wheat the amount of the levy payable in respect thereof by the producer, and shall, from time to time as required by the Wheat Research Committee, pay the proceeds of the levy into the Public Account:
- (b) Every flourmiller who delivers any flour or wheatmeal from his flourmill shall from time to time as required by the Wheat Research Committee, pay into the Public Account the amount of the levy payable by him in respect of the flour or wheatmeal.
- 6. The levies payable in accordance with these regulations by persons taking delivery of flour or wheatmeal from a flourmill shall be collected and paid into the Public Account in such manner as the Wheat Research Committee may from time to time direct or authorise.
- 7. On payment into the Public Account of the amount of any levies as aforesaid, the person paying them shall forward to the Director-General of the Department of Scientific and Industrial Research at Wellington a statement containing such particulars with respect to the levies comprised in the payment as the Wheat Research Committee may from time to time require.
- 8. Every person who acts in contravention of or fails to comply in any respect with any provision of these regulations commits an offence and shall be liable on summary conviction to a fine not exceeding £5.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations consolidate and amend the Wheat Research Regulations 1954.
