AMENDMENT NO. 4**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 9th day of April 1973

THE HON. W. E. ROWLING PRESIDING IN COUNCIL

PURSUANT to section 17 of the Scientific and Industrial Research Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Wheat Research Regulations 1966, Amendment No. 4, and shall be read together with and deemed part of the Wheat Research Regulations 1966\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of May 1973.

**2. Levies increased**—(1) The principal regulations are hereby amended by revoking regulation 4 (as amended by regulation 2 of the Wheat Research Regulations 1966, Amendment No. 3), and substituting the following regulation:

“4. The following levies are hereby imposed—

“(a) On all wheat grown in New Zealand and sold or delivered to a flourmiller or to a grain merchant, there shall be payable by the producer a levy computed at the rate of 10c for every tonne of wheat so delivered by him:

“(b) On all flour and wheatmeal delivered by a flourmill, there shall be payable by the flourmiller a levy computed at the rate of 15c for every tonne of flour or wheatmeal so delivered by him:

“(c) On all flour and wheatmeal received from a flourmill, there shall be payable by the person taking delivery thereof a levy computed at the rate of 15c for every tonne thereof:

“Provided that until the 1st day of January 1974 the levy imposed by paragraph (a) of this regulation shall be computed at the rate of 10c for every 50 bushels of wheat so delivered by the producer.”

(2) The Wheat Research Regulations 1966, Amendment No. 3, are hereby revoked.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

The regulations, which come into force on 1 May 1973, increase the rate of levy imposed in respect of wheat research. In the case of wheat the increase is postponed until 1 January 1974.

The new rate of 10 cents for every tonne (1000 kilograms) of wheat, which comes into force on 1 January 1974, is the equivalent of 13.6 cents for every 50 bushels of wheat. The existing levy, which continues until that date, is at the rate of 10 cents for every 50 bushels of wheat.

The new rate of 15 cents for every tonne (1000 kilograms) of flour and wheatmeal, which comes into force on 1 May 1973, is the equivalent of 13.6 cents for every short ton of flour and wheatmeal. The existing levy is calculated at the rate of 10 cents for every short ton of flour and wheatmeal.
