ORDER IN COUNCIL

At the Government House at Wellington, this 18th day of

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Public Safety Conservation Act, 1932, there being a Proclamation of Emergency now in force under that Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

---

REGULATIONS

1. (1) These regulations may be cited as the Waterfront Strike Emergency Regulations 1951, Amendment No. 4, and shall be read together with and deemed part of the Waterfront Strike Emergency Regulations 1951\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the date of their notification in the *Gazette*.

2. (1) Regulations 3, 5, 6, 8, 9, 15, 16, and 17 of the principal regulations are hereby revoked.

(2) The revocation of the said regulations shall not—

(a) Affect the liability of any person for any offence committed before the commencement of these regulations :

(b) Affect any appointment of a Receiver or other act made or done pursuant to the principal regulations before the commencement of these regulations.

EXPLANATORY NOTE

[*This note is not part of the regulations, but is intended to indicate their general effect.*]

These regulations revoke all the provisions of the Waterfront Strike Emergency Regulations 1951, except regulations 1 and 2, which are formal, and the following substantive regulations :—

Regulation 4, as to offences in relation to a declared strike, including the printing, publishing, and distribution of unlawful pamphlets, &c. :

Regulation 7, under which the Public Trustee has been appointed Receiver of the property of certain deregistered unions :

Regulation 9A, prohibiting the registration of trade unions except with the consent of the Minister of Labour :

Regulation 10, authorizing the employment of members of the armed forces :

Regulation 11, as to the control of admission to wharves :

Regulation 12, as to the offences of counselling any person to commit a breach of the regulations or to refrain from working :

Regulation 13, as to threats and intimidation :

Regulation 14, as to picketing :

Regulation 18, as to the power of entry and search.
