An Act to amend the Criminal Justice Act 1985

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Criminal Justice Amendment Act 1993, and shall be read together with and deemed part of the Criminal Justice Act 1985 (hereinafter referred to as the principal Act).
- (2) This Act shall come into force on the 1st day of September 1993.
