### BE IT ENACTED by the Parliament of New Zealand as follows:

#### 1 Short Title and commencement

- (1) This Act may be cited as the Criminal Justice Amendment Act (No 2) 1999, and is part of the Criminal Justice Act 1985 ("the principal Act").
- (2) This Act comes into force on the day after the date on which it receives the Royal assent.

### 2 Minimum periods of imprisonment
