BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Civil List Amendment Act 1985, and shall be read together with and deemed part of the Civil List Act 1979 (hereinafter referred to as the principal Act).
- (2) Except as provided in section 3(3) of this Act, this Act shall come into force on the day on which it receives the Governor-General's assent.
