## 12 Annual report

- (1) This subsection substituted s 202(1) of the principal Act.
- (2) Notwithstanding any other provision whatsoever, it shall be sufficient compliance with any requirement that a report and statement of accounts be presented by the Director-General to the Minister in respect of any time within the period commencing with the 1st day of January 1971 and ending with the 31st day of March 1972 for the Director-General to present, or to have presented, to the Minister the report and statement in respect of that time as soon as practicable after the said 31st day of March 1972.
