An Act to amend the Road User Charges Act 1977

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Road User Charges Amendment Act 1979, and shall be read together with and deemed part of the Road User Charges Act 1977 (hereinafter referred to as the principal Act).
- (2) Section 9 of this Act shall come into force on a date to be fixed by the Governor-General by Order in Council.
- (3) Except as provided in subsection (2) of this section, this Act shall come into force on the day on which it receives the Governor-General's assent.

2 Confirmation of increases in road user charges As required by section 20 of the principal Act, the Road User Charges (Rates) Order 1979 is hereby confirmed.

As required by section 188A of the Transport Act 1962 (as inserted by section 28 of the principal Act), the Transport (Allocation of Motor Spirits Duty) Order 1979 is hereby confirmed.
