An Act to amend the Road User Charges Act 1977 and other related Acts

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Road User Charges Amendment Act 1981, and shall be read together with and deemed part of the Road User Charges Act 1977 (hereinafter referred to as the principal Act).
- (2) Except as provided by subsection (3) of this section, this Act shall come into force on the 1st day of April 1982, or such earlier date as may be appointed by the Governor-General by Order in Council.
- (3) Sections 1, 3, and 4 of this Act shall come into force on the day on which this Act receives the Governor-General's assent.

2 Interpretation

- (2) *This subsection amended the proviso to the definition of the term **gross laden weight** in section 2(1) of the principal Act.*
- (3) The Road User Charges Amendment Act 1979 is hereby consequentially amended by repealing section 4(2).

3 Confirmation of increases in road user charges

As required by section 20 of the principal Act, the Road User Charges (Rates) Order 1981 is hereby confirmed.

4 Road user charges rates

(2) Section 21 of the principal Act shall not apply in respect of the substitution by subsection (1) of this section of a new Schedule 3 to the principal Act.

(3) Section 4(1) of the Road User Charges Amendment Act 1980 and the Schedule thereto are hereby consequentially repealed.

(4) The Road User Charges (Rates) Order 1981 is hereby revoked.
