Counties insurance empowering

13 Management of business of company

- (1) This section shall be read together with and deemed part of the Counties Insurance Empowering Act 1941.
- (2) Notwithstanding anything in the State Insurance Act 1990, it shall be lawful for the New Zealand Counties Co-operative Insurance Company Limited and the State Insurance General Manager from time to time to enter into agreements for the management of the company's business by the said General Manager, on such terms and subject to such conditions as may be agreed upon between the company and the said General Manager.
- (3) While any such agreement as aforesaid remains in force the company's auditor shall, notwithstanding anything in the Companies Act 1955, be the Audit Office, which for that purpose shall have and may exercise all such powers as it has under the Public Finance Act 1977 in respect of public money.
- (4) This section shall be deemed to have come into force on the 1st day of January 1944.

In subsection (2) a reference to the "State Insurance Act 1963" was substituted, as from 18 October 1963, for a reference to the "State Fire Insurance Act 1908" pursuant to section 38(1) State Insurance Act 1963 (1963 No 38). This reference was in turn substituted, as from 28 June 1990, by a reference to the State Insurance Act 1990 pursuant to section 24(1) State Insurance Act 1990 (1990 No 36). See regulation 3 State Insurance Act (Vesting) Order 1990 (SR 1990/142).

In subsection (2) the words "the State Insurance General Manager" were substituted, as from 18 October 1963, for the words "the State Fire Insurance General Manager" pursuant to section 36(4) State Insurance Act 1963 (1963 No 38).

In subsection (3) the reference to the "Companies Act 1955" was substituted, as from 1 January 1957, for a reference to the "Companies Act 1933" pursuant to section 474(1) Companies Act 1955 (1955 No 63).

In subsection (3) a reference to the "Public Revenues Act 1953" was substituted, as from 1 January 1954, for a reference to the "Public Revenues Act 1926" pursuant to section 120(1) Public Revenues

Act 1953 (1953 No 73). This reference was in turn substituted, as from 1 April 1978, for a reference to the “Public Finance Act 1977” pursuant to section 163(1) Public Finance Act 1977 (1977 No 65).
