*[Repealed]***An Act to amend the Social Security Act 1964****1 Short Title**

This Act may be cited as the Social Security Amendment Act 1972, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).

- (1) Subsection (1) of section 3 of the principal Act is hereby amended by repealing the definition of the term **family maintenance allowance** (as inserted by section 2 of the Social Security Amendment Act 1968).
- (2) Section 2 of the Social Security Amendment Act 1968 is hereby consequentially repealed.

- (1) The principal Act is hereby further amended by repealing section 19.
- (2) Notwithstanding the repeal of section 19 of the principal Act and of clause 2 of Schedule 2 to the principal Act, that section, and that clause (as set out in the Schedule to the Social Security Amendment Act 1971), shall continue in force and operate in respect of every person who attained the age of 60 years on or before the 1st day of November 1972, as if such repeals had not been made.
- (3) This section shall be deemed to have come into force on the 5th day of July 1972.
