## **An Act to amend the Social Security Act 1964**

**BE IT ENACTED** by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

### **1 Short Title**

This Act may be cited as the Social Security Amendment Act 1978, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).
