1 Title

This Act is the Social Security (Clothing Allowances for Orphans and Unsupported Children) Amendment Act 2015.

2 Commencement

This Act comes into force on 1 July 2018.

3 Principal Act

This Act amends the Social Security Act 1964 (the principal Act).

4 New section 29B inserted (Clothing allowance for orphans and unsupported children)

After section 29A, insert:

29B Clothing allowance for orphans and unsupported children

- (1) This section applies if, under section 363 of the Oranga Tamariki Act 1989, the rates of payment to persons or organisations in whose charge a child or young person is placed under section 362 of that Act include a clothing allowance.
- (2) A person who receives an orphan's or unsupported child's benefit in respect of a child is entitled to receive a clothing allowance for that child in the same amount or at the same rate as the clothing allowance referred to in subsection (1).

Section 4 new section 29B: amended, on 14 July 2017, by section 149 of the Children, Young Persons, and Their Families (Oranga Tamariki) Legislation Act 2017 (2017 No 31).
