#### 1 Title

This order may be cited as the Animal Control Products Limited Vesting Order 1992.

#### Note

# 2 Interpretation

(1) In this order,—

**The Act** means the Animal Control Products Limited Act 1991

Company means Animal Control Products Limited

Council means the Agricultural Pests Destruction Council constituted under the Agricultural Pests Destruction Act 1967 **Poison factory business** means the business operated by Animal Control Products at the poison factories in Wanganui and Waimate and consisting of the manufacture, sale, and other disposal of poison and poisoned baits.

(2) Any term or expression that is not defined in this order, but that is defined in the Act, has the meaning given to it by the Act.

# 3 Vesting of property and liabilities of Agricultural Pests Destruction Council in company

- (1) The property and liabilities of the Council to which this clause applies, being property and liabilities set out in a list prepared pursuant to section 6 of the Act by the Minister of Agriculture and the Minister of Finance dated the 9th day of June 1992, shall vest in the company on the 1st day of July 1992.
- (2) This clause applies to:
