Amendments to Schedule 1 of principal regulations

Regulations

1 Title

These regulations are the Accident Compensation (Motor Vehicle Account Levies) Amendment Regulations 2015.

2 Commencement

These regulations come into force on the day after the date of their notification in the *Gazette*.

3 Principal regulations

These regulations amend the Accident Compensation (Motor Vehicle Account Levies) Regulations 2015 (the **principal regulations**).

4 Schedule 1 amended

- (1) In Schedule 1, in each item that relates to a make and model of vehicle identified in columns 1 and 2 of the amendment table,—
 - (a) replace the information in the third column of Schedule 1 (year) with the information set out in column 3 of the amendment table opposite that make and model of vehicle; and
 - (b) replace the information in the fourth column of Schedule 1 (band) with the information set out in column 4 of the amendment table opposite that make and model of vehicle.
- (2) In this regulation, **amendment table** means the table set out in the Schedule of these regulations.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations come into force on the day after the date of their notification in the *Gazette*. They amend the Accident Compensation (Motor Vehicle Account Levies) Regulations 2015 (the **principal regulations**) to correct the bands to which some light passenger vehicles are allocated for the purpose of determining the motor vehicle levy payable for those vehicles under regulation 5 of the principal regulations.
