Regulations

1 Title

These regulations are the Accident Compensation (Motor Vehicle Account Levies) Amendment Regulations 2017.

2 Commencement

- (1) These regulations come into force immediately after the commencement of the principal regulations on 1 July 2017.
- (2) See regulation 3 (which defines principal regulations).

3 Principal regulations

These regulations amend the Accident Compensation (Motor Vehicle Account Levies) Regulations 2017 (the **principal regulations**).

4 Schedule 2 amended

- (1) In Schedule 2, item relating to Volvo V70, replace "2000 to 2006" with "2000 to 2016".
- (2) In Schedule 2, item relating to Volvo XC70, replace "2000 to 2006" with "2000 to current".

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect. These regulations—

- amend the Accident Compensation (Motor Vehicle Account Levies) Regulations 2017 (the **principal regulations**); and
- come into force immediately after the commencement of the principal regulations on 1 July 2017.

The principal regulations prescribe the rates of motor vehicle levy, motorcycle safety levy, and fuel levy. These regulations make some corrections to Schedule 2 of the principal regulations.
