1 Title

These regulations are the Accident Insurance (Regulator's Funding Levy) Regulations 2001.

2 Commencement

These regulations come into force on the day after the date of their notification in the *Gazette*.

3 Interpretation

In these regulations, **Act** means the Accident Insurance Act 1998.

4 Rate of Regulator's funding levy

- The rate of the levy payable by every insurer under section 236 of the Act for the financial year ending on 30 June 2001 is \$0.176 per \$1,000 of outstanding liability for claims under accident insurance contracts.
- (2) The levy is exclusive of GST payable on the levy.

5 Payment of levy

The levy is payable by an insurer to the Regulator within 10 days after the insurer receives from the Regulator a notice that the levy is payable.
