### **Title** This order is the Administration (Prescribed Rate of Interest) Order 2008.

### 2 Commencement

This order comes into force on 1 July 2008.

### **3** Application

This order applies to all legacies, and to all arrears of annuities, unpaid at the close of 30 June 2008.

### 4 Rate of interest of 8.4% prescribed

This clause prescribes for the purposes of section 39(2)(b) of the Administration Act 1969 the rate of 8.4% per year.

### **Explanatory note**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 July 2008, increases from 7.5% to 8.4% the rate of interest payable on unpaid legacies and arrears of annuities under section 39(2)(b) of the Administration Act 1969.

### 1 General

### 2 Status of reprints

### 4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legisla-

tion reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint. In outline, the editorial changes made in reprints under the au-
