1 Title and commencement

- (1) This order may be cited as the Biosecurity (Hawkes Bay Regional Animal Pest Management Strategy) Crown Obligations Order 1998.
- (2) This order comes into force on 10 July 1998.

2 Interpretation

In this order, unless the context otherwise requires,—

Financial year has the same meaning as in section 2(1) of the Public Finance Act 1989

Hawkes Bay Regional Animal Pest Management Strategy means the pest management strategy approved by the Hawkes Bay Regional Council on 26 June 1996.

3 Pest control on land administered by Department of Conservation

- (1) The Hawkes Bay Regional Animal Pest Management Strategy applies to the Crown to the extent that the Crown must (so far as is practicable) carry out work in accordance with that strategy, to the value of \$21,972 each financial year, on land owned by the Crown and administered by the Department of Conservation under the Conservation Act 1987 or under any Act listed in Schedule 1 of the Conservation Act 1987.
- (2) The obligations in subclause (1) are subject to the limitation in regulation 4.

4 Additional limitations on work

The Crown's obligation to carry out the work applies only to the pests specified in the Schedule and the obligation does not exceed the amount specified for that pest.
