Biosecurity (Canterbury Regional Pest Management Strategy) Crown Obligations Order 1998: revoked, on 6 November 2008, by clause 3 of the Regulations Revocation Order 2008 (SR 2008/367).

PURSUANT to section 87(2) of the Biosecurity Act 1993, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, makes the following order.

**1 Title and commencement**

- (1) This order may be cited as the Biosecurity (Canterbury Regional Pest Management Strategy) Crown Obligations Order 1998.
- (2) This order comes into force on 10 July 1998.

**2 Interpretation**

In this order, unless the context otherwise requires,—

**Canterbury Regional Pest Management Strategy** means the pest management strategy approved by the Canterbury Regional Council on 24 April 1998

**Financial year** has the same meaning as in section 2(1) of the Public Finance Act 1989

**General administrative functions** means setting standards, inspection, enforcement, monitoring, surveillance, provision of advice or information, education, direct control (including biological control) of pests, research into biological control, administration, or management.

**3 Pest control on land administered by Department of Conservation**

- (1) The Canterbury Regional Pest Management Strategy applies to the Crown to the extent that the Crown must,—
  - (a) So far as is practicable, carry out work in accordance with that strategy to the value of \$624,490 each financial year, on land owned by the Crown and administered by the Department of Conservation under the Conservation Act 1987 or under any Act listed in Schedule 1 of the Conservation Act 1987:
  - (b) Pay the amount of \$30,585 each financial year to the Canterbury Regional Council for general administrative functions as specified in that strategy.
- (2) The obligations in subclause (1) (a) are subject to the limitations in regulation 4.

**4 Additional limitations on work**

The Crown's obligation to carry out the work specified in regulation 3(1)(a) applies only to the pests or groups of pests specified in the Schedule and the obligation does not exceed the amount specified for that pest or group of pests.

**5 Application of order**

This order applies to the financial years commencing on 1 July 1998, 1 July 1999, and 1 July 2000.
