1 Title and commencement

- (1) This order may be cited as the Biosecurity (Marlborough Regional Rabbit Pest Management Strategy) Crown Obligations Order 1998.
- (2) This order comes into force on 10 July 1998.

2 Interpretation

In this order, unless the context otherwise requires,—

Financial year has the same meaning as in section 2(1) of the Public Finance Act 1989

General administrative functions means setting standards, inspection, enforcement, monitoring, surveillance, provision of advice or information, education, direct control (including biological control) of pests, research into biological control, administration, or management

Marlborough Regional Rabbit Pest Management Strategy means the pest management strategy approved by the Marlborough District Council on 22 May 1997.

3 Pest control on land administered by Department of Conservation

- (1) The Marlborough Regional Rabbit Pest Management Strategy applies to the Crown to the extent that the Crown must,—
 - (a) So far as is practicable, carry out work in accordance with that strategy, to the value of \$10,000 each financial year, on land owned by the Crown and administered by the Department of Conservation under the Conservation Act 1987 or under any Act listed in Schedule 1 of the Conservation Act 1987:
 - (b) Pay the amount of \$175 each financial year to the Marlborough District Council for general administrative functions as specified in that strategy.
- (2) The obligations in subclause (1)(a) are subject to the limitation in regulation 4.

4 Additional limitation on work

The Crown's obligation to carry out work applies only to rabbits.

5 Application of order

This order applies to the financial years commencing on 1 July 1998, 1 July 1999, and 1 July 2000.
