Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 26 May 2011 (that is to say, on 27 May 2011), is made under the Corrections Act 2004. It declares the land described in the *Schedule* to be a corrections prison to be known as the Mount Eden Corrections Facility (replacing the Auckland Central Remand Prison).

This notice revokes the Penal Institutions (Auckland Central Remand Prison) Notice 2001.
