Cook Islands Amendment Act Commencement Order (No 2) 1959

Cook Islands Amendment Act Commencement Order (No 2) 1959: revoked, on 20 September 2007, by section 7(2) of the Cook Islands Amendment Act 2007 (2007 No 49).

Preamble

WHEREAS by subsection (2) of section 1 of the Cook Islands Amendment Act 1957 (hereinafter called the Act) it is provided that Parts 1, 2, and 3 and sections 95 and 96 of the Act shall come into force on the date to be appointed for the commencement thereof by the Governor-General by Proclamation, and different dates may be so appointed for the purpose of different sections and Parts of the Act: And whereas by Proclamation dated the 27th day of August 1958¹ certain portions of the Act were brought into force on the 1st day of September 1958, except in Niue: And whereas by Proclamation dated the 25th day of March 1959² certain further
