1 Title

This order is the Commodity Levies (Nelson–Marlborough Dredge Oysters) Amendment Order 2006.

2 Commencement

This order comes into force on 9 September 2006.

3 Principal order amended

This order amends the Commodity Levies (Nelson–Marlborough Dredge Oysters) Order 2001.

4 New clause 2A inserted

The following clause is inserted after clause 2:

“2A Extension and expiry

This order is extended until the close of 9 September 2012 and then expires.”

5 Interpretation

The definition of **company** in clause 3 is amended by omitting “, on the commencement of this order, as the Challenger Dredge Oyster Fishery Management Company Limited” and substituting “, on the commencement of the Commodity Levies (Nelson–Marlborough Dredge Oysters) Amendment Order 2006, as the Challenger Oyster Management Company Limited”.
