12 May 2011 (after being spent on 2 April 1998), by clause 3 of the Regulatory
Reform (Revocations) Order 2011 (SR 2011/99).

PURSUANT to section 19 and section 28 of the Compulsory Retirement Savings Scheme Referendum Act 1997, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following order.

1 Title

This order may be cited as the Compulsory Retirement Savings Scheme Referendum Order 1997.

2 Interpretation

Terms and expressions used in this order that are defined in the Compulsory Retirement Savings Scheme Referendum Act 1997 have the meanings so defined.

3 Closing date for referendum roll

The date for the closing of the referendum roll is 15 August 1997.

4 Closing date for voting period

The date for the closing of the voting period is 26 September 1997.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order specifies 2 dates for the referendum on the proposed compulsory retirement savings scheme.

First, it specifies 15 August 1997 as the date on which the referendum roll closes. The referendum roll will accordingly include all persons whose names are lawfully on any electoral roll on 15 August 1997. It will be used (together with a supplementary roll) for dispatching voting papers for the referendum and for processing votes cast at the referendum.

Secondly, it specifies 26 September 1997 as the date on which the voting period will close. The voting period commences on the 21st day before the closing date. It will accordingly commence on 5 September 1997.
