Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 15 May 2003, is made under section 126 of the Criminal Justice Act 1985. It declares the land described in the Schedule to be a community work centre, to be known as the Cass Street (Ashburton) Community Work Centre.

The notice enables the existing centre in Ashburton to relocate from 7 Cass Street to 68 Cass Street.
