Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 3 October 2002, is made under section 126 the Criminal Justice Act 1985. It declares the land described in the *Schedule* to be a community work centre to be known as the Church Street (Palmerston North) Community Work Centre.

The Periodic Detention Centre known as the David Street (Palmerston North) Periodic Detention Centre will close when the Church Street (Palmerston North) Community Work Centre becomes operational. The periodic detention centre notice that constituted the David Street (Palmerston North) Periodic Detention Centre is revoked by this notice.
