Order

1 Title

This order is the Children, Young Persons, and Their Families (Minimum Rates of Payment for Board and Lodgings) Order 2012.

2 Commencement

This order comes into force as stated in clause 3(3).

3 Adjustment of minimum rates of payment in respect of board and lodgings of children and young persons

(1) This order adjusts the rates that—

- (a) are the minimum rates of payment to persons and organisations in whose charge a child or young person is placed pursuant to section 362 of the Children, Young Persons, and Their Families Act 1989; and
- (b) are determined under section 363(1) of that Act; and
- (c) were in force immediately before the commencement of this order.
- (2) The rates that this order adjusts are increased by 1.77%.
- (3) By virtue of section 363(8) of the Children, Young Persons, and Their Families Act 1989, this order—
 - (a) comes into force on 1 April 2012; and
 - (b) applies to the rates payable in respect of the board and lodgings of children and young persons on and after that date.

4 Consequential revocation

The Children, Young Persons, and Their Families (Minimum Rates of Payment for Board and Lodgings) Order 2011 (SR 2011/12) is revoked.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 April 2012, increases the minimum rates of payment to persons and organisations in whose charge a child or young person is placed pursuant to section 362 of the Children, Young Persons, and Their Families Act 1989.

The increases reflect the 1.77% increase in the New Zealand Consumers Price Index from the December 2010 quarter to the December 2011 quarter (calculated for all quarters using the CPI All Groups excluding cigarettes and other tobacco products).

Notes

1 General

2 Status of reprints

4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as "of this section" and "of this Act")
