1 Title

- (1) These rules are the Domestic Violence Amendment Rules (No 2) 2002.
- (2) In these rules, the Domestic Violence Rules 1996¹ are called "the principal rules".

2 Commencement

- make it clear that those rules do not apply to proceedings to which the Family Courts Rules 2002 apply; and
- remove provisions that relate solely to the jurisdiction of Family Courts under the Domestic Violence Act 1995.
