#### Order

#### 1 Title

This order is the Education (Early Childhood Centres) Regulations Revocation Order 2016.

#### 2 Commencement

This order comes into force on 1 June 2016.

#### 3 Revocation

The Education (Early Childhood Centres) Regulations 1998 (SR 1998/85) are revoked.

#### 4 Revocation of this order

# **Explanatory note**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 June 2016 and is revoked on 30 June 2016, revokes the Education (Early Childhood Centres) Regulations 1998 (the **principal regulations**). The principal regulations addressed licensing, health and safety standards, and education standards for early childhood centres. The principal regulations were replaced by the Education (Early Childhood Services) Regulations 2008, but continued to apply under the transitional provisions in section 319K of the Education Act 1989 to existing licensed centres and service providers whose application for a licence under the principal regulations had not yet been determined. The transitional provisions are now spent.
