**Explanatory note**

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on 31 March 2008, amends the Fisheries (Interim and Annual Deemed Values) Notice 2003 by inserting new interim and annual deemed values for spiny (red) rock lobster (CRA1 to CRA9), packhorse rock lobster (PHC1), and southern blue whiting (SBW6A, SBW6B, SBW6I, and SBW6R).

The new values apply on and from the fishing year commencing on 1 April 2008.
