Fisheries (Interim and Annual Deemed Values) Amendment Notice (No 2) 2007: revoked, on 29 September 2015, pursuant to clause 9(1) of the Fisheries (Total Allowable Catch, Total Allowable Commercial Catch, and Deemed Value Rates) Notice 2015 (LI 2015/211).

Pursuant to section 75 of the Fisheries Act 1996, the Minister of Fisheries, after consultation in accordance with section 75A of that Act, gives the following notice.

1 Title

This notice is the Fisheries (Interim and Annual Deemed Values) Amendment Notice (No 2) 2007.

Note

This notice is administered by the Ministry for Primary Industries.

2 Commencement

This notice comes into force on 30 September 2007.

3 Application

This notice applies to fish, aquatic life, or seaweed taken on or after 1 October 2007.

4 Principal notice amended

This notice amends the Fisheries (Interim and Annual Deemed Values) Notice 2003.

5 Annual deemed values

Clause 6 is amended by revoking paragraph (a) and substituting the following paragraphs:

- (a) the amounts per kilogram specified in the third column of Schedule 1 in the case of the following stocks:
 - (i) all stocks of anchovy, blue shark, cardinal fish, frostfish, garfish, ghost shark, green-lipped mussel, knobbed whelk, leatherjacket, lookdown dory, mako shark, moonfish, paddle crab, pale ghost shark, parore, pilchard, porae, porbeagle shark, prawn killer, Ray's bream, ribaldo, rough skate, ruby fish, sea perch, smooth skate, spiny dogfish, sprat, swordfish, trumpeter, and yellow-eyed mullet:
 - (ii) the individual stocks ELE3, ELE5, SCH2, STA1, STA2, WWA1, WWA2, WWA5B, WWA8, WWA9, and WWA10:
- (ab) in the case of stocks specified in Schedule 1A, the amounts per kilogram specified for those stocks in the third column of that schedule for the appropriate level of catch specified in the second column of that schedule:

- (1) Schedule 1 of the principal notice is amended by omitting the items relating to BAR1, BAR4, BAR5, BAR7, BCO3, BNS2, FLA3, GUR3, HOK1, HPB3, JDO2, JDO7, LIN1, LIN2, LIN3, LIN4, LIN5, LIN6, LIN7, ORH1, ORH7B, RCO3, SCH1, SKI2, SNA2, SNA7, SNA8, SPD1, SPD3, SPD4, SPD5, SPD7, SPD8, SPO2, SWA1, SWA3, SWA4, TAR1, TAR2, TAR7, TAR8, TRE2, WAR3, WWA5 and WWA6.
- (2) Schedule 1 of the principal notice is amended by inserting, in their appropriate alphabetical order, the items set out in Schedule 1 of this notice.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect on 1 October 2007, sets new interim and annual deemed values for certain stocks caught on or after that date within the quota management system.

Worthy of note are—

- deemed values are set for prawn killer stocks, which enter the quota management system on 1 October 2007;
- the new *clause 6(ab)* and *Schedule 1A* provide for a system of differential deemed values whereby the annual deemed values for certain stocks may vary in the manner specified for the particular stock according to the level of catch in excess of a fisher's annual catch entitlement.
